Legitimacy

Data protection legislation, article 6.1. e.

People affected

Those covered by the law and to whom the law is relevant.

Rights

Those concerned have the following rights:

- Information as to whether the city council of Donostia is in possession of their personal data.
- Access to their personal data, requesting the correction of false information, its removal when appropriate, for instance if the reasons for which it was collected are no longer relevant.
- In particular circumstances, requesting:
 - A limit to the use of data. In such cases, the city council of Donostia will only store the data to defend itself or to meet its obligations.
 - The data not being used. In such cases the city council of Donostia will stop
 using the data unless there are serious legal reasons in order to defend itself
 from possible demands. Decisions to rescind the automatic removal of data
 may also take place.
